SUMMARY OF RULES AND VALUE ADDED SERVICES

- 1. Exhibition Grounds or Construction Site Delivery**
Exhibition grounds and Special site deliveries will be an additional surcharge of min \$75.00 or \$1.75/cwt.
- 2. Free Time for Pickup and Delivery**
Free time allotted will be 15 minutes for shipments up to 5000lbs, 30 minutes between 5001 and 10,000lbs, 45 minutes between 10,001 and 20,000lbs, and 1 hour for more than 20,000lbs. Additional time will be charged at \$80.00 per hour with a minimum of \$20.00. Fort McMurray area will be \$130.00 per hour with a minimum of \$40.00.
- 3. Protective Service**
Freeze protection provided at a cost of 15% of the freight charges with a minimum of \$20.00. Temperature control is not provided.
- 4. Valuation Liability**
Maximum carrier liability if \$2.00 per pound unless a declared value is stated on the bill of lading. Valuation in excess of \$2.00 per pound is charged at 2% of the excess value, with a minimum charge of \$10.00. Limitation on declared value will be \$25.00 per pound or \$50,000 whichever is less.
- 5. Appointment Deliveries/Notification Prior to Delivery**
Shipments will be subject to a \$20.00 charge per appointment or \$10.00 per call ahead. Carrier will not accept any liability for costs arising from missed appointments or late deliveries. Storage charges will apply to appointments not given within 48 hours. One Network users will be \$30.00.
- 6. Residential Delivery / Mall Delivery**
A surcharge of \$35.00 for the first 100 lbs plus \$1.75/cwt thereafter will be assessed.
- 7. Long Freight**
Freight over 12 feet in length will be subject to a \$50.00 surcharge.
- 8. Re-delivery of Freight**
Will be subject to a minimum surcharge of \$45.00 or \$3.55 per cwt to a maximum of \$200.00
- 9. Helper / Lumper / Swamper**
Additional unload/load help is provided at \$50/hour. Minimum of 4 hours per person.
- 10. Power Tailgate**
A surcharge of \$1.75/cwt with a minimum of \$35.00
- 11. C.O.D. Fee**
Will be 6% of C.O.D. amount. minimum of \$25.00. A \$20.00 surcharge will be issued for cancellations.
- 12. Pallet Handling**
CPC skids will be returned at \$35.00 for the first skid plus \$2.00 per additional skid. All other skids will be \$20.00 for the first skid plus \$2.00 per additional skid.
- 13. After Hour Delivery**
Shipments that require delivery beyond our regular hours of 6am to 6pm, will be subject to \$50.00 surcharge over and above delivery rate.
- 14. Sunday/Holiday Delivery or Pickup**
Will be subject to a \$175.00 per vehicle surcharge over and above regular delivery rate.
- 15. Tarping Charge**
Will be subject to a charge of \$100.00 for 28' and \$150.00 for 48' trailer load.
- 16. Dangerous Goods/Explosives**
Will be provided at a charge of 7% of the freight charges with a minimum of \$15.00 and a maximum of \$45.00.
- 17. Trailer Detention**
A fee of \$60.00 per dry van or \$100.00 per heat controlled unit per day will be assessed for all trailers spotted in excess of 24 hours.
- 18. P.O.D. Requests**
Free on the webpage or Charges per P.O.D. requested will be \$10.00 for 1-6 months after delivery, and \$25.00 for shipments 6 months or older.
- 19. Changing Billing Terms (after invoicing)**
There will be a charge of \$10.00 applied when a bill is rebilled from Prepaid to Collect or vice versa.
- 20. Storage Charges**
Will be charged at \$1.25cwt with a minimum of \$10.00 per day. Free time 48 hours.
- 21. Saturday Delivery**
A \$1.75/cwt, Min \$35.00, Max \$175.00 charge in terminal locations, plus truckload to towns beyond servicing terminal.
- 22. Bond Charges**
A surcharge of \$2.00/cwt with a minimum of \$35.00.

Rates are based on weights of not less than ten pounds per cubic foot. Shipment occupying more than 10 linear feet of trailer space will be assessed a 1000lbs per linear foot or actual weight, whichever is greater. When due to the shape or packaging of a shipment, other freight can not be loaded on or around the shipment; the height and/or width used in calculating the cube will be 8 feet. Flat deck shipments will be subject to cube of 1000lbs per linear foot of deck used. Personal goods must be paid in advance, no claim to Carrier.

All rates and surcharges are based on the credit terms that all payments are received within net 30 days. Late payments will be assessed an interest surcharge of 1.5% per month. GST and Fuel Surcharge are not included in any of the quoted rates.
